## **INTRODUCTION**

Contract Management is an unique and important discipline of Project Management. It is in fact emerging as a discipline which is a blend of administrative, technical and legal aspects, with a flavor of art.

Many of the problems in the Management / Administration of Contracts arise from the attitude of the owner's engineers and the contractors towards each other and to the work, although it has to be appreciated by both that they have a common objective of completing the work within the time specified and the rates quoted. During the implementation of the contract, both have to work towards the fulfillment of the objectives specified in the Agreement.

It will be in the best interest of the project that the Contract Management is handled by the owner or the appropriate authority with tact and care without getting into unnecessary disputes with the contractor or allowing undue benefits or advantages to him. The whole process should be gone through under the provisions of the Indian Contract Act, 1872 (amended by Act No.4 of 2003) and The Arbitration & Conciliation Act 1996.
